WHITE PAPER GIVES REASONS FOR RAID ON AGENCY

LONDON, Wednesday.- A White Paper issued to-day, giving informa-tion relating to acts of violence in Palestine states that information in possession of the Government when it undertook the recent action in Palestine led it to draw the followin ing conclusions:

1. The Haganah and its associate force, the Palmach, working under the political control of prominent members of the Jewish Agency, have been engaging in carefully planned movements of sabotage and violence under the guise of "Jewish Resistance Movement.

2. The Irgun Zvai Leumi and Stern Group worked since last autumn in co-operation with Haganah High Command in certain operations.

3. The broadcasting station "Kol Israel," claiming to be the voice of the Resistance Movement and working under the general direction of Jewish Agency, has been supporting these organisations.

Evidence for these conclusions was derived mainly from three sources:

1. Information showing that be-tween the 23rd of September, 1945, and the 3rd of November, 1945, seven telegrams passed between London and Jerusalem and a further telegram on the 12th of May, 1946, copies of which are interpreted and set out in the White Paper. 2. Various broadcasts by Kol

Israel between the 31st of October, 1945, and the 23rd of June, 1946, referring to specific acts of violence and substance and sabotage.

Information on various dates 3 derived from a pamphlet "Hamaas," a publication of the Stern Group, a puor" "Herut," a publication of the Stern Group, "Herut," a publication of Irgun Zvai, and "Eshnav," a publication of the Jewish Resistance Movement, ex-amples of which are set out in the Paper. The evidence relates to widespread sabotage operations of the 31st October, 1st November, 1945, 20/25th February, 1946, and 16/18th June. 1946. 16/18th June, 1946.

All three military organisations participated in these actions, not only causing serious destruction, but also loss of life. The White Paper gives details of the attacks on rail-ways, police launches and the Haifa Refinery on the 31st October and 1st November, 1945, stating that the railway attacks were carried out by Palmach, also on the same night the I annach, also on the same hight the Irgun Zvai attacked Lydda station, while the Stern Group blew up the oil refinery, adding that the incident was carefully planned as part of a deliberate policy intended as a warning to the Government of the consequences, if the Government did not comply with the wishes of the Yishuv. The Jewish Agency Executive was not prepared to wait for a declaration of Government policy, but decided to cause one serious incident in order to influence the policy, which was plain from the telegrams.

The White Paper gives the text of a telegram purporting that it was sent by Dr. Sneh from Jerusalem to London on the 23rd of September, 1945, also a telegram from Dr. Joseph and a reply from Mr. Shertok from London dated 12th October, and further cables between London and Jerusalem purporting to show that the Agency sought and obtained the co-operation of the dissident or-ganisations, Irgun Zvai and Stern Group, and also agreed to their isolated actions.

The White Paper further claims that "Kol Israel" was working with the agreement of the Jewish Agency. The Paper further claims that "Pal-mach" attacked R.A.F. radar station at Haifa on February 20, 1946, and two days later attacked the Mobile Force Camps at Shaffa, Kfar Vitkin and Sarona, while on February 25, the Irgun Zvai and the Stern Group followed it up with attacks on air followed it up with attacks on air fields at Lydda, Petach Tikvah and Quastina, which were intended as a second warning, since the first warn-

ing was disregarded. Lastly the White Paper quotes the attacks on road and rail bridges by Haganah and the Stern Group's attack on the Haifa railway workshops and the kidnapping of British officers as well as the text of "Kol Israel" broadcasts stating that the Jewish Resistant Movement had destroyed the bridges

conclusion the White Paper In says that the foregoing evidence was not complete. All the evidence in the Government's possession and the instancs quoted were not a complete list of the incidents of violence and sabotage during recent months. "It is a fact that during the first

six months of 1946 nearly fifty separate incidents, involving violence, have occurred resulting in many cases in loss of life and great material damage. The above operations which were of a widespread character and caused extensive damage were followed by the kidnapping of the British officers, and it was no longer possible to adopt a passive attitude. Unless the Government was prepared to yield to threats of violence and to abandon all hope of establishing law and order, it was bound to take active steps against the persons and organisations who made themselves responsible for planning and carrying out the outrages.

BRILLIANT WEISSENBERG RECITAL

The "maturity" bogus so often heard about in regard to young musi-cians was convincingly dispelled by Sigi Weissenberg in his brilliant second recital at the City Hall on Tuesday night.

So often any deficiencies in a young artist's performances are attributed to "immaturity" that one might just as well search for staleness in older artists. It should be remembered that artists. It should be remembered that all virtuosi commenced their concert careers as youngsters, and in most cases proved themselves accomplished artists from the very start.

The writer recollects Menuhin's first The writer recollects Menuhin's first appearance in London. He was only twelve. The audience was a very dis-tinguished one, including all the musi-cal celebrities of the time, and an atmosphere of tense expectation pre-vailed. Menuhin gave a flawless in-terpretation of Brahms' violin con-certo that astounded his critics.

Sigi Weissenberg we have In pianist who combines a keen sense of musical intellect with complete of musical intellect with complete mastery over his instrument. The astounding boldness and clearness of his polyphonic playing of the Bach Italian concerto, the deep musical in-sight he displayed in the slow move-ment and the rhythmic finale made it a most creditable performance. But it was in the great Liszt Sonata in B Minor that Weissenberg reached the heights of artistic perfection, and the audience showed its appreciation in no uncertain manner.

In the second half followed works by the impressionist Debussy. The left hand Nocturne by Scriabine was played as I have never heard it played before. The Flying Bee by Rimsky-Korsakov and the colourful Triana by Albeniz were likewise a veritable delight to listen to.
