CATTLE.—Oxen: Super prime, 35/- per 100 lbs., from £13 10s. to £15; Prime heavy, 34/- per 100 lbs., £10 10s. to £13; Baby beefers, £7 10s. to £9; Good mediums, 26/- to 28/- per 100 lbs., £7 10s. to £8 10s.; Ordinary mediums, 22/- to 24/- per 100 lbs., from £5 to £6 10s.; Compounds, 18/- to 21/- per 100 lbs., £3 to £4. Tollies: two and three year old, open market only, £2 10s. to £4. Bulls: Heavy, good condition, £6 to £8. Cows: Super prime, 35/- per 100 lbs., £8 10s. to £9 10s.; Prime heavy, £6 10s. to £7 10s.; Medium to good medium, £3 10s. to £5.

Open Market or South West Africa.

SHEEP.—Merinos: Prime heavy, 6½d. per lb., from 24/- to 28/-; Medium to good medium, 18/- to 22/-; Old Ewes, medium to prime, 12/6 to 18/-; Old Ewes, poor, 5/- to 8/-. Capes and Bastards: Prime heavy, 24/- to 28/-; Medium to good medium, 18/- to 22/-. Lambs: Prime medium, 19/- to 28/-. Lambs: Prime Bastards or Persians, 19/- to 21/-; Medium to good medium, 14/- to 17/6. Goats: According to size and condition, 5/- to 14/-.

PIGS.—Bacon pigs, best quality 6d. to 6½d. per lb. should weigh 180 lbs. Overweight and underweight from 4d. to 5d. per lb. live weight. Porkers: Best quality, 4d. to 5d. per lb., should weigh 50 to 100 lbs. Porkers: Medium, 2d. to 3½d. per lb., Larders: Fat heavy, 4d. to 5d. per lb. Good quality pigs sell well, but poor pigs are practically unsaleable.

REMARKS.—Good supplies of cattle and sheep came forward the past week, and we have much pleasure in advising clients of an improvement in prices, especially for prime stock, we can now again advise clients to rail fat stock.
