**London Rothschilds and Hungarian Loan. PROTEST BY VIENNA JEWISH PAPER.**

A vigorous protest against the action of the London Rothschild firm in granting a loan to Hungary, where the Jews are being persecuted, is made in a leading article in the "Neue Welt." About twenty years ago, the paper says, there was a big Jewish scandal. Shortly after the pogroms in Russia the Czar found himself in financial difficulties, and he sent his agents to the European capitals in order to raise a loan. They were met with refusals by many Jewish financiers, including the Rothschilds in London, Paris and Vienna. There was only a certain Herr von Taussig in Vienna, then Director of the Land Credit Institution, who declared his willingness to float the loan. Austrian Jewry was indignant, because Taussig was one of the Honorary Vice-Presidents of the Vienna Jewish Community. Protest demonstrations were held, and the Jews on the Stock Exchange boycotted Taussig. Taussig explained that he had demanded and received from the Russian Government as a condition for the loan that the Jews of Russia should be given better treatment. The protests, however, did not cease, and Taussig was compelled to resign his position in the Jewish community. A few weeks after the conclusion of the loan there were fresh pogroms in Homel and Bialystock. So much for the assurance obtained from the Czarist Government by Taussig.

Twenty years later, the paper proceeds, Bloody Horthy sends out his agents to raise a loan. The London Rothschild firm immediately agrees. The fact that it was Horthy who had hundreds of Jews cut up with swords and bayonets and thrown into the Danube is not allowed to interfere with its business. Taussig at least was an upstart, but the Rothschilds are no upstarts.

And to crown it all the paper goes on, last Friday, at the meeting of the Budapest Municipality, when the details of the Rothschild loan were made known, there were cries of: "Rothschild has bribed the Premier and the Minister of the Interior, and has swindled us." All over Hungary the cry is now raised: "The English Jew has swindled the poor Hungarian Fatherland."

The Hungarian Jews, the "Neue Welt" says, will be made to feel the effect of this. The anti-Semite treads the Jews under his feet, and when he needs money he always finds a Jew ready to give it to him, and then he takes the money and says the Jews have swindled him, and he treads the Jews again under his feet.

The House of Rothschild, the paper continues, is not one of which the Jews need be ashamed. The Paris Rothschild created the Jewish colonies in Palestine, a work which will bring immortal honour to the name of Rothschild. The Vienna and London Houses of Rothschild, too, have so far stood up for the honour of the Jews, but now a Rothschild has sinned against the honour and the interests of the Jewish people.

The paper concludes by pointing out that the Minister of the Interior, M. Seitovsky, who has been responsible for the raids and deportations of Jews from Hungary, has a brother who is director-general of the Rothschild Bank in Budapest. It is not surprising, it says, that just at this moment the Minister of the Interior has stopped the raids, but as soon as the affair with regard to the loan is over the raids will probably be resumed.

**Murderer of Jew Sentenced. PENAL SERVITUDE FOR EX-OFFICER.**

The ex-Czarist officer Rumkin, who on July 9th attacked two Jews named Wilensky and Bichovsky while they were waiting for a train at the railway station of Khailar, on the East China Railway, killing Wilensky and seriously wounding Bichovsky, has been sentenced to penal servitude for life. When he was arrested, Rumkin, who was a member of the pogromist band of Baron Unger-Sternberg which in 1921 massacred the entire Jewish community of Urga in Mongolia, confessed that he had not known the two men, but he had been unable to contain himself on seeing Jews and he had wanted to kill them. He wanted to kill all Jews.

The town of Manchouli, where the trial took place, was crowded with White Guardists, of whom large numbers are now living in China as political refugees, and efforts were made to bring influence to bear on the Chinese Court to pronounce a verdict of acquittal. The witnesses on Rumkin's behalf were all ex-Czarist officers, who urged that Rumkin, like the whole Russian people, was a victim of the Jews. A former Czarist general, named Czernich, who now occupies a position in the police force in Khailar, said in the course of his evidence that the Jews dominated Russia and had seized the property of the Russian estate owners. Rumkin, he said, had been a large estate owner in Russia, and it was not surprising that when he had seen two Jews he had been seized with an overpowering desire for vengeance.

Rumkin alleged that Wilensky had called him a White Bandit. A large number of witnesses, however, denied this. Bichovsky, who came to Khailar in order to settle the affairs of his murdered friend, was threatened by White Guardists and had to leave the town.

The Court awarded ten dollars a month for life to Wilensky's widow and ten dollars a month each to her two children until they come of age. Bichovsky was awarded a hundred dollars compensation.
