There are many examples of how deep apartheid has cut into the minds of the maid-generation...and one can only gaze in wonder, mouth open at the 'reactions' of people who have no idea of who they are accountable to, what their responsibilities are and why they are there in the first place.

At best one can politely refer to these people in key state media positions as nieve, at worst they are downright out-of-line and should be reminded of this.

I refer now to yet another recent example of a 'state' radio incident that took place between a lady called SHONA and a Port Elizabeth promoter. This promoter, incidently, has had the same problems with RADIO ALGOA as I have had with RPN. Not as acute. However, certain 'officials' take certain issues personally, and like at RADIO FORT NATAL (and now it seems at RADIO 5) they 'refuse' to associate themselves with some local initiatives because so-and-so said this or that about me....NO MORE AIR SUPPORT FOR HIM FROM NOW ON...the word is out "THIS PERSON IS TO BE AVOIDED" along with ANYTHING heshe may care to promote.

Back to the RADIO 5 issue. The PE Promoter is told:

Radio 5 can not see its way clear to promote or advertise the BAR NONE PE FESTIVAL on June 19/20th because (quote) "PE Bands are not considered national, and they are not good enough...."

Who, on subsidised State radio makes those sort of decisions about a local community who are going out of their way to hold an entirely local show? They have no 'names/stars' (no budget) and no Duran Durans, Undercovers, 2 Unlimited's and other imported disasters....who are Radio 5 obligated too? If they are a 'commercial' independent why are they still operating from Aukland Park?

What is the DAC and SAMA's position regarding State Radio and the importance of creating an own South African Culture?

What is happening in the 'new South Africa' and where exactly do we start drawing the line between a people's radio station (SABC), the SA Record Industry and all those regional stations who are entrenching, not changing the status-quo by acting as a window to the world for the record companies?

They claim there's no new SA Music or bands because no record landed on the desk this week!

One can understand the mediocrity and banality of supposed SOUTH AFRICAN music mags like TOP 40...they do not get public funding. I don't think that their attempts at being South African fools anybody but them...eg: the May issue is a ludicrous case in point...they even have a libelous article on "The empty Void of SA Music" in a magazine that's covered with empty imported rubbish...see enclosed TOP 40 article.

Radio 5 are NOT TOP 40. The politicians are pretending hard to being democratic while the artists' outlets are being closed up and becoming more difficult to access than ever before. We must lobby the NAI, SAWCU, MANA, NCC and others to do something about it before we go back to 1748.....we DO NOT NEED ANOTHER FAK, or, as KOOS says, swopping die Ou Baas for a New Boss.
