**Commemoration of International Human Rights Day,  
10 December, 1991.**

The Human Rights debate in South Africa is very topical. Both the ANC and the South African Law Commission have published draft bills of rights for comment. It is certain that the new South African constitution will incorporate a bill of rights.

It is imperative that all South Africans, particularly the youth who have been in the forefront of the struggle for liberation, should understand how a bill of rights works and the issues that underpin a genuine democracy. Unless a "Human Rights Culture" can be engendered in South Africa, the struggle for democracy and liberation will have been lost.

On 10 December 1948, the General Assembly of the United Nations adopted and proclaimed the Universal Declaration of Human Rights (UDHR). Regrettably, it was not adopted by South Africa and seven other countries.

December 10, 1991, marks the 43rd anniversary of this historic occasion.
