THE ZUID-APRIKAAN.

CAPE TOWN, APRIL 13, 1890.

It will perhaps appear strange that, with the prospect of obtaining from Lord Grey the voluntary concession of a Representative Assembly for this Colony, the Colonists are nevertheless on the point of making a movement in this important question...

The Colonists should be so framed as to ensure no interference with the provisions of salary and allowances to all public functionaries, officers, and public institutions, as now established by Her Majesty; and the House of Assembly should not have the power of exercising any control over appointments of any description.

Now, we maintain that it is those very "provisions of salary and allowances"—that enormous drain upon the amount of their hard earned means, which have formed the main subject of their complaints and grievances, and which have mainly tended to compel them to endeavour, by obtaining some wholesome restraint, to prevent similar waste.

The result of this injustice, an appalling civil list, is, upon the concession of a Representative Assembly, to be bequeathed to the Colony as a legacy, which will always oppress and interrupt and soon convince them that they are really disappointed in their meaning; that, instead of being favored with the substance, they are put off with the shadow.

The late Legislative Council, which had not the confidence of either friend or foe—possessed the privilege of having the several Estimates submitted to them, and the official constitution-mongers of course deem it very convenient to propose that the Estimates, as last passed by that Council, should remain unaltered and placed beyond the interference of the intended Legislative Assembly.

Mr. ROXBURGH, that staunch colonial reformer, not only admits the justice of this privilege, but in his recommendations for the improvement of the government of Lower Canada, makes the following observations on this important point, more appropriate than which cannot be found:—

It has been proposed by some to reserve a portion of the revenue, and to place it wholly beyond the control or inspection of the Assembly. This scheme, however plausible may be the reasons by which it is supported, is a dishonest one. It is a side-whisk attempt to escape from responsibility—a specious method of keeping the executive free from wholesome control.
