

MEMBERSHIP OF THE STELLENBOSCH DISCUSSION FORUM

- The forum should be inclusive and representative
 - ✓ ■ The applicant should be an organisation *within* the area of jurisdiction region of the SM/I-CMC/KTC
 - Membership shall be available to *soo town die gebied is*
 - local government bodies, and
 - organisations which represent substantial sectors of the wider community, such as civic associations, resident associations and the local structures of political parties *supplies bodies - ~~area~~ water boards*
 - Each applicant should subscribe to the declaration of intent of the SDF
 - Each applicant should submit the following in writing:
 - its goal/aims/objectives or constitution
 - a list of office bearers ✓
 - *nature details* of membership *member functions*
 - extracts from the minutes of its last AGM ✓
 - There shall be two categories of participants in the forum, viz.
 - members and
 - bodies with observer status *employee and employee organ*
 - Observer status shall be granted to Chambers of Commerce *and* Sakekamers, and to other stakeholders in the local community such as umbrella bodies for sporting *and* cultural organisations *service* *made use*
 - Observer status *may* be granted *with* participatory rights i.e. have same speaking rights as members but shall not be entitled to vote *and representative* *be elected onto ad hoc groups as engaged agricultural committees*
- Position of local authorities, not within the present SM/I-CMC/KTC area of jurisdiction region (Pniel; Kylemore; Johannesdal; Jamestown) to be reviewed when the Regional Demarcation Board has adjudicated new boundaries for local government.
