PRESS STATEMENT

The purpose of the meeting was to address issues which the ANC felt prevented them from returning to the SDF and directly concerned the Town Council. The Town Council also asked that issues preventing the desired progress towards a single town council be put on the agenda for discussion.

The discussions were in no way of a decision-making nature and served primarily to clarify the positions as well as to confirm the commitment of two of the major role-players in the Stellenbosch Discussion Forum .

After the two and a half hour meeting, discussions had reached the stage by which both the Stellenbosch ANC and the Stellenbosch Town Council delegations felt it was possible to look at dates for the SDF meetings necessary to get the negotiating process going once again.

Meetings of the Constitutional Working Committee and its technical committees will meet on Monday, 8th August to prepare the way for a full SDF meeting later in that same week.

Both groups are committed to the setting up of the Transitional Local Council as soon as possible and have set the 15th August 1994 as a date by which all outstanding issues, which can be locally negotiated, should be resolved.
