The death occurred last Thursday in Johannesburg of Dr. A. J. Kuny, the well-known pioneer communal worker. The deceased arrived in South Africa forty years ago and lived for a time in the Volksrust district, where he practised for many years, acting as District Surgeon to the late Transvaal Republic. He retired fourteen years ago and settled in Johannesburg.

During this time he devoted himself mainly to communal affairs. He was connected with the Berea Synagogue and was instrumental in connection with the building of the Berea Talmud Torah, and was associated with the laying of the foundation stone of that institution. He was also a member of the Gemillus Chesed and a worker for a number of other institutions.

The deceased leaves a widow, a son (Dr. B. Kuny, of Edenville) and two daughters (Mrs. Polnay and Mrs. Shakanovsky), to whom the deepest sympathy is extended in their bereavement.
