"DAVAR" AND "HAARETZ" PROHIBITED IN POLAND.

The Polish Government prohibited the circulation of two of the largest Hebrew papers in Palestine, the "Davar," official organ of the Palestine Labour Federation, and "Haaretz."-J.T.A.

VIENNA JEWISH COMMUNITY.

Dr. Desider Friedman was re-elected President of the Vienna Jewish Community for a period of four years at the first meeting of the new Executive. Dr. Jakob Ehrlich, a Councillor of the Vienna Municipality, and Engineer Robert Stricker, were elected Vice-Presidents for a period of one year.

The Executive of the Board of the Vienna Jewish Community consists entirely of Zionist members.

The Winter Relief Department of the Vienna Jewish Community is expected to spend 150,000 schillings for relief purposes this year. The Department is distributing coals and food among the needy members of the community and provides clothes and food for children. The Department also helps the needy members of the community with the payment of their rates, and has opened free restaurants in several districts of the city.—J.T.A.

BRIT HACHAYAL LEGALISED IN CZECHO-SLOVAKIA,

Prague.

The Czecho-Slovak authorities have legalised the Brit Hachayal in Czecho-Slovakia.

Mr. Z. H. Waxman, head of the World Executive of the Brit Hachayal, is expected to arrive in Prague shortly in order to assist the organisation of the Brit Hachayal in the country.-J.T.A.

Defamation Trial in Denmark

CHIEF RABBI TO GIVE EVIDENCE

Copenhagen.

Proceedings in the trial of six Fascist editors for publishing anti-Jewish defamations have been of a purely formal nature and have taken up only a very short time. In view of the fact that the Danish court procedure is very slow, the verdict is not to be expected for many months.

During the proceedings it was pointed out on behalf of the court that the reports about statements of prominent Danish theologians were not correct and that it was the counsel for the accused and not the court who demanded that Chief Rabbi Dr. Friediger should be invited as a witness, in order to be cross-examined about the truth of the different "incriminating" quotations from the Bible and the Talmud published in the Fascist press.

It is considered likely that the reason for the demand for the cross-examination of Chief Rabbi Dr. Friediger was that the counsel of the accused Fascists wished to make use of his personal appearance in the court, in order to defame his personal character and the Jewish religion. In place of Dr. Friediger, however, the solicitor and the secretary of the Jewish community of Copenhagen, Arthur Henriques, appeared in court and lodged an official protest against the invitation, and demanded that the counsel for the accused should give in writing the questions which they wanted to put to him.

The counsel for the accused, Mr. Pontoppidan, insisted, however, on the personal

The General Committee of the Council meets at least twice annually. It will be remembered that its members were addressed last June by the Very Rev. Dr. J. H. Hartz, Chief Rabbi of the British Empire, on "Marriage, Divorce and the Position of Women in Judaism."
