during the year, and a feature of note has been the rapid rate at which industrial expansion has taken place. We were advised recently by a Minister of the Union Parliament that the industrial development of South Africa has been advanced twenty-five years in view of the many requirements occasioned by the war as well as by general industrial needs. Industrialists have indeed risen to the occasion.

Other Industrial Interests.

Great progress has been effected in the manufacture of steel and iron products to which the Union Steel Corporation (of South Africa), Ltd., has contributed a substantial quota. New developments in refractories and other special products now being manufactured by the Vereeniging Brick and Tile Company (a subsidiary of the Vereeniging Estates, Ltd.), have been in line with the exceptional demands, and consumers are now reaping the benefits of the extensive research work which has been, and continues to be, methodically carried out. Although the speeding up of industrial outputs has been to an appreciable extent due to war requirements and the limitations imposed on imports from oversea, I nevertheless predict that subject to a sympathetic and wise policy being applied by the Government in financial and economic issues, the progress which has been achieved will be of a permanent nature, and when the war is over it will be found that South Africa has established

new foundations in industry which will make not only for increased future allround development but will add to the selfsufficiency of the country as a whole.

It is with the deepest regret that we have to record in July last the death of Mr. Julius Weil, who served on the board of your Company from its inception. His wise counsel and loyal co-operation will be sadly
