DAY OF MOURNING Wednesday, March 14th

THE Executive Council of the S.A. Jewish Board of Deputies Calls upon South African Jewry to observe Wednesday, March 14, as a Day of Mourning for the five million Jews of Europe who have died a martyr's death at the hands of the Nazis.

The ecclesiastical authorities, following the example of the Palestine and U.S.A. Rabbinates, have proclaimed the day as a Fast Day.

All Hebrew Congregations are expected to arrange special services in the afternoon of that day. It is also suggested that wherever possible, special services or gatherings for children be organised.

Employers of labour are urgently requested to facilitate attendance of the Jewish members of their staff at the Synagogue services.

There will be no public or private Jewish entertainments, and members of the Jewish community are expected to refrain from attending theatres, bioscopes, etc., throughout the 24 hours ending midnight, March 14.

In Johannesburg, the Board is arranging a mass meeting to take place at the City Hall on the Wednesday evening. It is hoped that similar meetings will be held in other large centres.

Fuller details will be announced next week.

In view of the short time available, the Board makes an earnest appeal to all Jewish communities to take in hand the necessary arrangements immediately. It also appeals for the full co-operation in this observance of every Jew and Jewess. Let 'hem on this day not only mourn for their martyred brethren, but dedicate themselves anew to saving and rehabilitating the survivors and obtaining for the 'Jewish people its rightful place in a world of justice and peace.

The Passing Scene — By "Commentate"

Louw Attacks Jews Again-But Bremer Denounces Racialism

THE remarks made in this column last week, on the subject of Nationalist attempts to modify their policy, were given further point by what occurred in the House of Assembly last Thursday. Mr. Eric Louw made allegations of malpractices and corruption in the Department of Defence and claimed that a number of Jewish firms were involved. "There is," he stated, "a certain section in this country which has been battening on the profits and spoils of this war—making money out of war contracts, out of the black market, and out of profiteering." He alleged that orders from the Department of Demobilisation were being diverted to five firms, and said it was no coincidence that all five firms were Jewish. Complaints had been made to the responsible Minister six months ago, but he had not acted. "One wonders," said Mr. Louw, "why the delay? One wonders whether some influence was brought to bear?" THE remarks made in this column

This insinuation provoked Mr. Abe Goldberg into calling out: "Say that outside and you will get six months!"

Mr. Louw went on to complain that "an alarming number of Jews are still entering the Union." Between 1939 and 1944, he said, a total of 16,118 had entered the country on temporary permits. There was no assurance that these people had left. No wonder there was growing resentment and nervousness in the country.

Actually, of course, those 16,118 permits were used in typical bogey style. Mr. Louw either knows or should know that most of the permits were issued for people in transit, or on visits, and that they are not in the country any longer.

"Local Julius Streicher"

Mr. P. V. Pocock (one of Pretoria's United Party Members) took up Mr. Louw's remarks in a vigorous fighting speech. Mr. Louw, he said, had denied that he was making any personal attacks. No one would believe that. "How does he get his reputation of being a Jew-baiter? He is becoming the Julius Streicher of South Africa." Mr. Pocock deplored the whole racialistic approach of the Nationalists. They were trying to stir up bitterness all the time,

Mr. J. M. Conradie (Rustenburg's United Party Member) agreed, and said that the racialistic speeches made by members of the Opposition had led to mass treachery during the

Then Dr. Karl Bremer got up Then Dr. Karl Bremer got up and caused a sensation by saying: "We have reached the stage in South Africa when we should be ashamed of ourselves—ashamed that we are still talking about matters of the past, and about differences between the parties which belong to the past."

which belong to the past."

It was time, he said, for all sections of the people to come together and co-operate for the welfare of South Africa. They must give the people something better than the "promises of Communist dictatorship." Every effort should be made to provide full employment and decent standards of living. If Communism or any other "ism" could provide this without revolution and anarchy, then he would not oppose Communism.

One may well ask what is behind

One may well ask what is behind this statement. Dr. Bremer is a leading member of the Nationalist Party and it is inconceivable that he would speak "without the book." The situation is one which merits careful attention. tention.
