Progress of Bikkur Cholim

THE fifth annual general meeting of the Bikkur Cholim Society took place at the Hebrew High School Hall

The Chairman, Mr. Louis Isaacson, presented his report for the year, showing that the membership of the society was well over 4,000. The financial position of the society was

very sound, the cash on hand being over £4,500. The society intends to devote these funds towards the cost of establishing a new convalescent home for chronic cases.

As usual, the society continued to carry out its comprehensive programme of visiting hospitals, which included regular visits to the General Hospital, the Transvaal Provincial Home, the Hope Home for Children and all the most important Nursing Homes, as well as numerous private cases. The work had been carried out by a small band of devoted workers and the Chairman made an urgent appeal to the audience to come forward to assist the noble work of visiting the sick.

During December, 1946, the society conducted the Bikkur Cholim Children's Seaside Camp and sufficient funds had been raised to send down a party of 73 children to Lakeside, Muizenberg, for three weeks. It is

hoped that with the generous support of the Johannesburg public, an even greater number may be sent down at the end of this year.

It was reported, with regret, that very little had been accomplished towards the establishment of the Convalescent Home, the participants being representatives from the Aged Home, Chevra Kadisha and this society. It was suggested that the Aged Home, which had to care for many chronic sick cases, should take the initiative in the establishment of a new Convalescent Home.

ADDRESS BY RABBI WEILER

Rabbi Dr. M. C. Weiler pointed out that the work of the society was not sufficiently known to the Jewish public of Johannesburg. He felt that more publicity was needed. He advised the meeting that two of his colleagues were regularly visiting the General Hospital. He suggested that the prisons should be visited, but it was pointed out that it would be more desirable for members of the clergy to do this work.

Mr. M. G. Marcus expressed his appreciation of the work done, but complained that there was insufficient publicity in connection with the meet-

Mr. S. Asher congratulated the Executive on the excellence of the Revenue Account and Balance Sheet. He also felt that the work of the society was not receiving sufficient publicity, and he suggested that all Jewish institutions should be approached to provide additional workers

Mr. H. Sadowsky deplored the fact that nothing had been done in the matter of the establishing of the Convalescent Home.
