ZUID-AFRIKAAN.

CAPE TOWN, JULY 10, 1848.

We proceed to give an outline of the proceedings of the Legislative Council. In doing so we beg to remind our readers, that in the course of the debate, various sentiments have been expressed by the Governor and others, upon which we intend to offer some remarks hereafter.

THURSDAY, JULY 6, 1848.

BEFORE proceeding to the order of the day, the Secretary to Government begged to say a few words in explanation of what had fallen from Mr. Ebdon on the subject of transfer dues; but as it appeared that the hon. member had been misunderstood, the matter was dropped.

Mr. Cloete requested that the amendment on the Ecclesiastical department proposed by him in the last meeting, be put to the vote, namely, that the Salary of the Archbishop be reduced from £400 to £200. Mr. Van der Byl seconded. The amendment was rejected by a majority of 7.

The Secretary to Government stated, that in consequence of the expressed opinion of this Council, that the expense for the Post Office should not exceed its revenues, and the Post Office Ordinance not having passed, he had reduced the estimate to £1,901 4, which was agreed to.

The estimate for the Civil Establishment, amounting to £45,741 9 6, was passed, including the additional allowances to the Civil Commissioners.

The Secretary to Government proposed, as promised by him, certain Resolutions on the subject of Education, which were unanimously approved of; the following gentlemen were appointed to constitute a Commission of Inquiry (2 to form a quorum) the Secretary to Government, Treasurer General, Attorney General, Messrs. Ebdon and Van der Byl: His Excellency said, he hoped that they would be ready with their report before the next meeting in October; at the same time observing that 12 years ago, when he left the Colony, he saw the S. A. College in a most thriving state, but he was sorry to find it had receded so much, for reasons unknown to him.

The Secretary to Government explained, and added, that it was caused by means beyond the reach of the Council of the College, that a Professor was daily expected from England, and it was hoped that it would thrive again; upon which it was resolved that the S. A. African College should also be included in the inquiry.

Medical Department.—On the question of Mr. Ebdon whether the Infirmary at Robben Island answered the purpose; the Governor stated that it was monthly visited by the Head of the Medical Department, and that the lunatics and paupers were properly attended to.

Police Establishment.—Mr. Cook, supported by Mr. Harries, remarked, that Graham's Town and Port Elizabeth were inadequately provided with Constables in comparison with Cape Town and other places, in as much as they were more needed in the first mentioned places on account of the vast number of vagrants and Fingoes, infesting these towns.

The Secretary to Government explained and added, that the number of constables assigned to each District, was in accordance with the reports received by him from the Civil Commissioners and Magistrates, and that they seemed satisfied with them; that he was still corresponding on the subject; that the Estimate contained a broad outline of the establishment, but that numbers should be added, whenever circumstances required it, adding as an instance, that at the request of Mr. Stockenström, he had been furnished with two additional constables.

Mr. Ebdon and Mr. Cook, supported Mr. Harries. The Attorney General gave an outline of the manner in which the Police Department in Cape Town had been established, in conjunction with the support of the Cape Town Municipality which bore a certain amount in the expenses, and said he thought that similar arrangements might be made by other Municipalities.

On the item "Pensions and retired allowances," Messrs. Ebdon and Cook remarked on the amazing extent to which it had accumulated. The first-mentioned gentleman again adverted to the superannuation fund, formerly proposed by him, and thought it was the duty and the interest of all civil servants to raise such a fund, from which they and their families might afterwards be supported, for it was necessary, he thought, that the public revenues were relieved from this charge. The latter gentleman hoped that all individuals, to whom pensions were in future allowed, would really deserve such consideration. He also stated his desire to see another name added to the list. The party for whom he contended was a very respectable woman, who had formerly lived in affluence, but was now reduced to extreme distress—he alluded to Mrs. Norden, the widow of the late Mr. Norden, who had been killed in action, whilst serving in the field as Captain of the Graham's Town Yeomanry. He would earnestly impress upon the Governor the favorable consideration of this particular case, inasmuch as anything the Council might vote by way of a pension, would afford her the greatest relief.

The Governor was glad this case had been brought to the notice of the Council. He felt it to be their duty to provide adequately for the widow in question, whose husband had been killed in defence of his country.

The Secretary to Government having stated that about 12 months ago a representation had already been made to the Secretary of State, recommending that a pension of £70 per annum (being the pay of the widow of a captain killed in action) be allowed to Mrs. Norden, it was unanimously agreed to add that sum to the pension list.

Allusion having been made by one of the members respecting Mr. Hough's pension and state of health, the Governor stated he was sorry to say that gentleman's health was very precarious—in fact he was on his "last legs."

On the item "Transport" it was observed by Mr. Cloete, that whereas the Secretary of State

had thought that £200 were sufficient to pay the travelling expenses of the Bishop, he did not see why he should have £400, and would therefore vote against it.

Mr. Cook objected to any grant whatever, because it was unfair towards other religious denominations who did not receive such favors. He would remind His Excellency that these grants would cause the most serious discussion throughout the Colony. History told them that religious dissentions had ever been a scourge to all countries; some of which had been entirely raised by them; and it was their duty, he thought, to guard against similar consequences.

The Governor did not anticipate such results, aware as he was of the good sense of the people. But if such dissensions, as dreaded by the hon. gentleman, were really to occur, he could only say that he would refuse to be their Governor.

Mr. Harries understood that the £200 alluded to in Earl Grey's despatch were merely in aid of the Bishop's travelling expenses, and he would therefore vote for the item as it stood.

The Governor informed the Council, that before the Bishop left England, Earl Grey had given him a promise that, whatever means he should want to complete the Episcopal establishment, would be readily conceded to him.

On the grant of £11,000 for Kafir Police, the Governor observed, that only one division of the Kafir Police had been estimated for. He had proposed a certain arrangement to the Secretary of State, and if this were not approved of, the Council would, in their next Estimates, have to provide for both divisions.

On the item "Emigration" (which was declared by the Governor to be an open question) a conversation took place relative to the difference of the costs attending the conveyance of Emigrants from the Mother Country to Table Bay and Algoa Bay. Mr. Harries recommended to have a supply every two months, instead of every six weeks. Mr. Cook was surprised at this view of the matter. In his opinion six weeks was a sufficient interval to dispose of any batch of Emigrants before the arrival of the next. But what he more particularly desired was that the vessels should come to Algoa Bay direct, and not touch first at Table Bay, and then bring the "refuse" there.

Mr. Cloete thought, that roads, harbours and emigrants were essential to develop the resources of the colony. But why was not the half of the surplus revenues devoted to the making of roads, for then they might soon be finished.

The Governor was opinion that it was necessary first to impart the emigrants to make the roads.

All the other members having also declared in favor of the item, it was passed.

On the subject of the grant (£2400) to the Roman Catholic Church, Mr. Ebdon observed that, having understood that this item had been put down by order of the Secretary of State, it was not so to oppose it. He thought, however, that it was inappropriate, if compared with the grant to the Dutch Reformed Church, inasmuch as the latter (with 72,000 members) was only £1900. He was afraid, also, that the allowance of this grant would lead other sects to ask the same favor, in full reliance that it would be conceded. And as His Excellency had expressed himself so favorably respecting the erection of Churches throughout the Colony, he intimated the intention of the inhabitants of Rondebosch to apply to Government for a grant for the enlargement of their Church.

The Governor replied that he would give no pledge ever; but whenever an application was made it would be considered on its own merits. As regarded the grant to the Catholic Church, he did not consider it disproportionate, because the Dutch Church had been longer established, and was better able to support itself. He must say that the Catholics were building a fine church, which would tend to embellish the City. The only thing was that the several others—they had commenced an ornamental building, without calculating the expense, and were now unable to finish it.

The whole of the Estimates having been passed, the Governor expressed his thanks to the Council for the support that had been given him, and for the unanimity of feeling which had prevailed throughout the debate.

The Council adjourned till Friday at 1 o'clock, when the Secretary to Government moved that the sum of £2,134 5, be entered upon the Estimates for Rents, which was carried.

The Secretary to Government also proposed a resolution, that a sum of £1,000 be granted to the Dutch Reformed Church at George.

The Attorney General in rising to second this resolution, as he had promised to do in a former meeting, stated, that the £1,000 for this grant were peculiarly circumstances; that the church, he believed, on the application of the late Landroos Van Kervel had been built by order of Government; that on the completion thereof, churchwardens had refused to take it over on account of the bad state of the building; that a correspondence had taken place between Government and the said Landroos, and that at last, upon a most emphatic letter of the then Secretary to Government Colonel Bird, the building had been forced upon them; that the churchwardens had quietly submitted, in consequence, and had considered it safer to take it over, than to be entangled with a law-suit. That shortly after, this building had to be propped inside and outside, and at last it was deemed necessary to pull it down and build another, which was done at a considerable expense, by which churchwardens incurred a debt of upwards of £2,000. That certain churchwardens, described in a Proclamation of the 1st April 1844, to be the persons entitled, had quietly submitted, in consequence, and had considered it safer to take it over, than to be entangled with a law-suit. That shortly after, this building had to be propped inside and outside, and at last it was deemed necessary to pull it down and build another, which was done at a considerable expense, by which churchwardens incurred a debt of upwards of £2,000. That certain churchwardens, described in a Proclamation of the 1st April 1844, to be the persons entitled, had quietly submitted, in consequence, and had considered it safer to take it over, than to be entangled with a law-suit.

The Attorney General replied, that he considered that Proclamation did not give them that power, and he looked upon it as an "April fool law."

Messrs. Cook and Harries stated, they hoped that applications under similar circumstances would be attended to. The motion was carried.

The Secretary to Government proposed that a sum of £1,917 be entered against the Municipality, for support of Police, in accordance with the Ordinance No. 1, 1846. This having been carried, the third reading of the Estimates was fixed for Monday (this day) at 1 o'clock.

Mr. Harries moved, that His Excellency be requested to lay upon the table the Blue Books of Sir Henry Pottinger and Sir H. Young, about the Colony.

The Attorney General remarked, that such motions in the House of Commons were always made with a certain proviso, as far as the public is concerned, &c.

The Governor said, I shall cause them to be laid upon the table, provided that I am not expected to read them.

Mr. Harries presented a Petition from the inhabitants of Port Elizabeth, regarding the law of inheritance, and gave a very fair and clear exposé of the cases which had given rise to that Petition.

Mr. Cook stated, that he had expected a similar Petition from Graham's Town, signed by about 600 persons, which, however, he had not received.

The Attorney General requested to postpone the further consideration of this petition till Monday next, when he would be prepared to answer certain observations, which fell from Mr. Harries, and at the same time to submit certain resolutions.

The Council adjourned till Monday (this day) at 1 o'clock.

their Shop Licences at the Town House, for the purpose of enregistering them, and paying thereon a fee of two shillings and sixpence—because they sell bread, and upon refusal threatening them with a legal prosecution.

Now, as there is no law, as far as we know, compelling the holders of Shop Licences, which they obtain from the Government on payment of £2 10, to have those Licences registered at the Municipal or any other office; and as the due publication, by the Distributor of Stamps, of all Licences issued, in the Government Gazette, is deemed a sufficient registration, we are at a loss to conceive on what authority the Municipality acts. Surely they are not at liberty to do as they like, but if unhappily such is presumed to be the case, we advise the Householders to have a meeting convened for the purpose of at once deciding the matter.

A report has been rife in town, since the arrival of the *Natut*, from Rio, that Mr. MONTAGU has been appointed Governor of St. Helena; another report, prior to this, assigned to the Honorable Secretary the Governorship of Mauritius.

Our Intelligence from Winburg is up to the 21st June, and it will be seen that our correspondent at that place throws considerable light on the event which seems to have led to the flight of the Resident Magistrate.

The subpoenaed notice, issued by order of Her Majesty's Commissioner, on Thursday last, denies that there has been any ground for such a course of proceeding on the part of that functionary; and it is therefore very probable that the defensive preparations mentioned by our correspondent had been occasioned by a too hasty belief in the same ill report. This, at least, is our sanguine hope, as nothing would certainly be more lamentable than an open defiance of established authority on the part of those Emigrants, who have as yet not seen the propriety to avail themselves of the privileges so liberally held out.

The following is the Government Notice referred to:—

Cape Town, 6th July 1848.
"Rumours, as false as perniciious, are afloat, that the Commissioner at Winburg was driven from his post by 300 armed Burgers. This Officer did leave his post upon the middle of the 21st June, and repaired to Bloemfontein, to the British Resident, who immediately sent him back again."
"The Districts of Caledon River and Bloemfontein are progressing in order and regularity to the full extent of the most sanguine expectation."

ALBERT.—BUFFEL'S VLEI.

(Communicated.)
Burgers' Dorp, June 18th, 1848.

Since I wrote last, matters have turned out more favorably over the Orange River. Pretorius has returned to Magaliesberg, and it seems that since the arrival of the Magistrates of that Division, all is going on much better than expected. There are parties who are still divided, and some dissatisfaction is expressed, but all begin to feel that they will be obliged to yield to British jurisdiction.

The Land Surveyors are making a flying survey of this district to form a general map. This has created a great deal of excitement amongst the Boers, all of whom express anxiety as to the tenure upon which it is intended they shall hold their farms. They are all very willing to pay the expense of surveying, &c., and have come forward to give all the assistance in their power to the Surveyors, supplying them with horses, &c.: at the same time stating, that if they are compelled to purchase their farms at the same rate as Crown lands in the Colony, they had better like their brethren have been rebels, and gone over the border, in which case they would have got farms for nothing.

The following series of important Resolutions were proposed by Mr. Norden, in a Meeting of the Commissioners of the Cape Town Municipality, held on Wednesday last, and unanimously adopted:—

1. That this Colony must be held to be of some importance, since it has recently been a cause of expense to Great Britain of upwards of a million of money sterling, in consequence of which, Earl Grey has been compelled to intimate that in the event of any future contest with the native Tribes, the Colony must be prepared to defray the expenses from its own resources.

2. That since the Colonists are thus apprised that they must defend themselves, it is but just and reasonable they should be allowed a voice in the management of their own affairs, with a proper and efficient check and control over the finances and expenditure of the Colony.

3. That the experience of—years since the formation of the council called "Legislative" has proved to demonstration the utter inutility and worthlessness of its constitution and character, it being acknowledged, that virtually and for all general purposes, and matters of importance, the inhabitants of this Colony are no more represented by the unofficial members of the so-called "Council" than the serfs of Russia or natives of Kamatschka.

4. That with the solitary exception of the stamp duty act, withdrawn by Government in consequence of the unanimous opposition of the whole Colony, the Petitions of the people but particularly of the Municipality and Inhabitants of Cape Town, against many grievances, have not only been wholly disregarded, but received by the organ of Government with marked contumely and insult, the Petitioners disgraced, their arguments ridiculed, and their facts so distorted and misrepresented as clearly to indicate the utter hopelessness of expecting redress from such a quarter.

5. That even if the present number of unofficial members were freely chosen by the people to give an honest and independent vote upon all Government questions, their endeavors would be rendered nugatory and unavailing, by being subject to be outvoted at any time by the official Gentlemen, who are compelled to support all Government measures, however opposed to their own convictions; in proof of which it is well known that some of them, had they dared to express an opinion, would have voted against the Road Tax Ordinance and the grants to the English Bishop.

6. That as the Legislature is at present constituted, Government has the power of passing arbitrary and obnoxious enactments under the semblance of the same being by the advice and approval of a Council; it therefore becomes a matter of serious consideration whether it would not be infinitely preferable that the Governor of the Colony should act solely upon his own views and responsibility, than to be under the necessity of resorting to so glaring a mockery of representation.

7. That entertaining an entire want of confidence in such a Council, it is the opinion of the Commissioners of the Cape Town Municipality that a Petition to Her Majesty the Queen should be drawn up, praying for its immediate abolition; and further, that Her Majesty's subjects in this part of the world may enjoy free institutions in accordance with the spirit of the times, upon the principle that taxation without representation is unjust and oppressive.

Report of the Directors at the Third Annual General Meeting of Members, held at the Society's Office, Cape Town, Monday, the third day of July, 1848.

ON presenting their third Annual Report, the Directors have again the pleasure of congratulating the Members on the success and uninterrupted progress of the Institution. In the course of last year, Ninety Three new Policies have been granted for the gross sum of £38,200, yielding in Annual Premiums the sum of £1,740 19 5, being an increase on the head over the preceding year of £38,800 on the sum insured, and £1,165 10 9 in the premiums, exclusive of interest on the same, added to the income of the Society.
The total amount remaining insured on the 31st May 1848, after deducting lapses and surrenders of Policies, was £211,450, and upon these the annual Premiums amounted to £3,355 2 2. The accumulated fund at that date, had reached the sum of £117,715 11 6, which has been laid out and invested in the following safe and available securities, viz:
On 1st Mortgage on Immovable property, £5,702 15 9
On Loans under Security of Shares in public Institutions, 4,115
On Loans on Security of Bonds, 485
Balance in the Bank, 412 15 9
Total, £11,715 11 6

The Society have to lament the loss of one of its Members, but of one only out of 383 during the year. This was Mr. Hendrik Pieter Moller, who it will be recollected, was suddenly cut off, in the prime of life, without any previous illness, the sum for which he was assured (£2500) was paid to his Widow.
The number of policies granted since the Society commenced its operation in May 1845, is 428, and the amount received in premiums and interest on capital, up to the 31st May last, was £15,783 10 6.

Taking into consideration the smallness of that class of persons in this colony, who have yet been accustomed to regard Life Assurance as an eligible mode of making provision for their families after their decease; and also the number of persons out of that small class who had effected assurances at other offices, previous to the establishment of this Society, which are of course continued, the number of policies issued, and the amount assured, during its short career, of three years, may well be regarded as a conclusive proof of the utility and the principles on which it is founded, and of its being in the full enjoyment of public confidence.
