## Welcome and apologies

Prof R Cawood was Chairman. It has since been decided that the secretarial work be assigned to Dennis Moss Partnership.

#### Comments on Zille Shandler's report

At this discussion of the process for community participation, the 4 steps in the two-stage process previously proposed were discussed. It was recommended that this two stage process be consolidated into one. It was agreed that this would be possible if a balance between bringing plans and proposals to the people and free participation and comment by the people be allowed. It was therefore agreed that the key issues be tested and familiarised before proposals are made. The policy proposals or guidelines then put forward would allow for greater public reaction. For this purpose also it was advocated that the proposal document, as well as any other preparatory documentation, make use of clear illustrations.

Zille Shandler's report was favourably received at the SDF meeting on the 18 May 1994.

## Next steps in the planning process

It was pointed out that there is a large interest by the broader Stellenbosch population in the SDF. It was therefore proposed that a special meeting for these role players and other interested or affected parties be convened on 2 August 1994. The SDF would remain as the core under the umbrella of the MDF. Each of the technical members of the sub-committee would also receive a copy of the GOPS document (enclosed). Each of the SDF members would receive a simplified document containing the content of the proposals, by Zille Shandler Associates, together with the invitations. Invitations would also be sent out to other interested parties or role-players and the meeting would be advertised, so maintaining the transparency of these meeting-come-workshops.

At the first open meeting proposed for the 2nd of August, the people themselves would appoint a Chairperson. Summarised versions of the proposals will be made available to all interested parties, while the full documentation will be available from Leon Fourie's office and the public library. The people themselves, then, will decide how to continue with the workshops and be represented geographically.
