Het is een populair gezegd geworden "dat menschen

het godsdienstig kunnen worden gemaakt door

Parlements Acten," en dat dit volkomen waar is zal

niemand betwisten. Er zijn evenwel andere middelen

waardoor dit kan worden bereikt, waaronder wy als

het voornaamste noemen het inplanten van goddeli-

ke waarden en voorschriften door Evangelisatie-

en Onderwyzers, die het oordeel hoeken om

te beoefenen wat zy prediken en leeren.

Wy gelooven dat er, by verryking gesproken, in

deze Kolo die eve. v. el godsdienstig onderwys gegeven

wordt als in eenig gedeelte van Europa. Of er hier

evenwel wezenlyk nut met gesicht wordt als da-

willen wy niet beslissen; maar het komt ons voor,

dat indien wy de uitgebreidheid van de bevolking

onzer Kolonie met die van Londen, Parys of

enige andere groote stad van Europa verge-

lyken, wy niet veel reden tot pogehen

hebben. Van waar komt dit? Wanneer

men beweert dat de oorsak te vinden is in de

gemange en onopgevoede bestanden waaruit onze

bevolking is zamengesteld, kan er hierin iets waars

opgevoeld worden; maar kan dit niet met evenveel

kracht worden toegepast op de bevolking van Londen

byvoorbeeld, zamengesteld als sy is uit onopgevoede

lieden uit bykans alle deelen der aarde?

Wy vreesen dat er ergens een gebrek moet bestaan,

en wanneer wy by iedere opvolgende zitting van h t

Hooge Gergrthof en de Rondzande Hoven, acton

van beschuldiging zien inbrengen tegen mannen en

vrouwen, niet behoorende tot de gekleurde klassen,

maar tot de hoegere en middelstanden der zamen-

leving, dan kunnen wy tot geen ander besluit komen

dan dat, in waarwil der zegeriverende verklaringen van

sommigen, wy veel reden hebben om over onze

tekortkomingen te blyven.

In enigs der door ons bedoelde gevallen waren de

beschuldigde partijen, door hun oogenzighylyk ged-

ruichlyk leven en wondel, waardig gesicht om zelfs

kerkelyke bedieningen te bekoemen; maar onder den

dekmantel van uiterlyke vroombheid werden misdaden

van den afschuwelyksten aard gesmeed en geploged.

Wy weten dat huichelaryk altyd een smet geweest is

en blyven zal op het menschyk karakter en niet

gheel kan worden uitgerooid. Maar oehoon in

vole gevallen huichelaryk haar kleed mogt hebben

geleien als de misdadigers, syn ons andere gevallen

bekend, waarin de overtreders hunne misdaden regt-

vaardigen door aanhalingen uit de Schrift. Hieruit

leiden wy af dat het leersteel gebrekklyk is. "Het

geloof is uit het gehoor." Door een burgerlyke

opleiding moet 's menschen gemoed worden voor-

bered, verlicht en ontweekt. Hy moet leeren te

redeneren, gevolgtrekkingen te maken, het onderscheid

te begrypen tussehen goed en kwaad, en volkomen

bekend gemaakt met syn hulpeelosen en afhankelijkten

staat en de betrekking tussehen het soepel en den

Soepper. Indien hy aldus voorbereid is—gelyk een

akker om het graan te ontvingen—zal hy in staat

syn om het volle genot van godsdienstig onderwys te

smaken, want syn gemoed zal voorbereid syn om de

waarheid te ontvingen.

Het is eene gebrekklyke kennis van onze roeping

en onze verantwoordelykheid als menschen, een

gebrekklyke kennis van onze verplichtingen jegens onze

naasten en het menschyk geslacht in het algemeen

die ons dikwerf doet afdwalen van het pad van

zedelyke opreghtheid naar den weg van dwaling en

misdad, en aanleiding geeft tot die voorbeelden van

zedelyke bedorvenheid, die ons geslacht tot schande

verstrekt. Laten onze godsdienst-onderwyzers en

de opvoeders der jeugd in het algemeen op deze

saken letten, met het doel om eenig gebrek te

herstellet welke heerscheude gevonden mogt worden,

solankten gezond stiel van burgerlyk en godsdienstig

onderwys voor het gebrekklyke is de plaats worden

gesteld.

THE Zuid Afrikaan.

Cape Town, January 23, 1865.

It has become a popular saying that "men cannot be made religious by Acts of Parliament," and that this is quite true will not be disputed.

We believe that, comparatively speaking, as much religious instruction is imparted in this colony as in any part of Europe.

There must be a deficiency somewhere, we apprehend, and when we see by the indictments preferred at almost every successive criminal session of the Supreme and Circuit courts against men and women, not belonging to the colored classes, but men and women belonging to the upper and middle classes of the community, we cannot help coming to the conclusion that notwithstanding the triumphant enunciation made in certain quarters, we have in reality much reason to blush at our shortsightedness.

In some of the cases to which we have just alluded the parties charged were, in consequence of their apparently godly life and walk, esteemed worthy even to occupy offices in the church; but under the mask of external piety crimes of the most revolting nature were matured and effectuated.

CRIMINAL SESSIONS.—The only three remaining cases were disposed of on Thursday. They were 1. The Queen vs Johannes Daniels, for rape; 2. PLUMSTED POST OFFICE.—This office has been re-established at Mr Byrne's shop, near the railway station, and letters and papers for Wynberg are now sent through the same. The mails for Mowbray, Roodbosch, Claremont and Plumsted will be closed at 7 30 a.m., 12 and 4 10 p.m., and sent by the trains, leaving at 8 15 a.m., 12 50 and 4 10 p.m. The return mails will be sent by the trains leaving the Wynberg station at 8 23 a.m., 2 10 and 4 16 p.m.

AIDED SCHOOLS.—The Superintendent General of Education has given notice that his report for 1864 will be finally closed on the 1st February next. MALMESBURY.—The Divisional Council has assessed a rate of three farthings in the pound upon all immovable property in the division. The Council purposes to establish a toll at the farm Romdoopte, near Mas-el-Banks Liver.

LAND RENT.—All arrears of quitrents for 1864, due in the divisions of Worcester and Robertson must be paid before the 31st March next, and those due in the division of Caledon, before the 30th of April next.

From the 15th April to the 15th Sept., one half more will be charged between 8 p.m. and 5 a.m., and from the 15th Sept. to the 15th April, between 8 p.m. and 4 a.m. Four-wheeled vehicles not provided with a remittance pay 1d. extra; if supplied with a patent brake, allowed 4d.
