

mere assertion of rights to older countries; but the acknowledgment of which has been, and thus still to be, a battle for a State, whose origin and story are such, as are the origin and the story of this land. We do not expect our neighbours and our contemporaries to abstain from comment upon what they deem to be wrong here; or from advice, or from counsel, or even from satire, upon the defects of our polity or of our people. We would even solicit them; but we are entitled to ask them to correct the impressions derived from their information of things as they were—not very long since—by the information they easily obtain, as to things as they are. The formal recognition of the Rights of Conscience, in a land which had, ignored them, is an epoch, in its history. It is a recognition infallibly heralding our advances. It is the distinctly pronounced dawn of a light whose power and effects will grow stronger, as it grows. No one, we think, with the capacity of observing, can doubt, that the ice is broken, that the fallow ground is being disturbed; that darkness is giving place to light. Errors and ignorances, and vices, and violence, which not very long since paraded themselves with swaggering mien, and to resist or even to laugh at which, was very often to incur a serious danger, are now compelled to be very chary of obtruding themselves. We have no apprehension at all that such scenes, as that which took place in the Court Room here some months ago, and on which we felt compelled to comment with some asperity, will occur again. Everybody was heartily ashamed of it; and that is a strong pledge against recurrence. And had it been known that such a thing was contemplated, it would have been prevented. But it is only a very few years ago, since that sort of thing was common. The landroost at the time, more than once to a revolver into court, and significantly placed it on the table before him. Those who formed the minority in opinion upon any public matter, only dared express their opinions at risk of broken heads. All that however is passed. The numerical minority now, not only state their opinions, but somehow often continue to give them practical effect. It is the principle of toleration, in other things than in Religion, which is at work. We differ, but we agree to differ, much more than we did. We don't so constantly enforce our views by arguments really as well as metaphorically, of a "knock down" character. A better "public opinion" is forming, and is sensibly beginning to control. "The bearers of burthen" may not feel "faint"; and there is still "much rubbish to be cleared away"; but the faintest is cheered by reasonable hopes; and the "rubbish"—recognised as only "rubbish"—is being cleared. There is much to be done, and it will take much time; much disappointment, vexation, and delay too, will distress too sanguine spirits, and every now and then there will be hearing, perhaps even an outbreak of the old devil. But it will be repressed, repressed not perhaps by force, but by the silent progressive power of an improved tone. And towards the forming and consolidating of this improved tone, we feel quite sure that a great impulse will be given by the resolution of the Volksraad which has suggested this article, and which concedes "full freedom of religious worship."

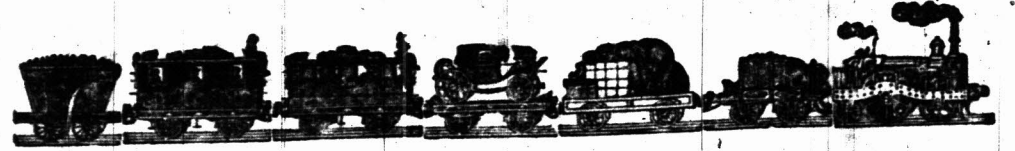
