By the courtesy of the Manager of the Standard a representative of this journal attended the dress rehearsal of Allen Doone's new production "The Parish Priest" which commenced last night just as our final formes were on the machine. The play is a domestic drama of a particularly charming type and is laid in a small American mining town, with an Irish population. The story concerns two families and the love affairs of the younger members, which, through the ambition of the newly-qualified young doctor, have become considerably tangled. This gives beautiful opportunity for the for the intervention of the village priest, Father Whalen, and his gentle influence gradually straightens things out, and the young doctor realises the error of his way and returns to his old love. Mr. Doone plays the part of Father Whalen, the simple minded, kindly old priest, with beautiful and convincing sincerity. He is admirably true to type and his work last evening was followed with real delight by his audience. In the third act, he sang "My old-fashioned Mother" delightfully and in response to persistent applause, repeated the last verse. The second honours of the evening fall to Mr. Tom Buckley, the veteran actor, whose artistic work has given so much pleasure during the season. Miss Keeley's portrayal of Nellie Durkin was as unaffected and charming as all her work has been, and Miss Ethel Bashford gave a good study of the part of Agnes Cassidy. Mr. Richard Scott has a congenial part as Tim Walsh, a miner, who was rattled into matrimony in spite of himself, by Miss Corrigan, the young lady from Sligo. The rest of the parts are equally as well played and the staging, which is excellent, provides a charming setting to what is a most desirable production.
