A Special General Meeting of Members of the Jewish Guild will take place at the Jewish Guild War Memorial Hall, Von Brandis Street, Johannesburg, on Sunday, July 12th, 1925, at 8 p.m., for the purpose of considering and, if thought fit, passing the undermentioned resolutions, with or without amendment:—

1.—That application be made on behalf of the Jewish Guild (Incorporated) to the Licensing Board, Johannesburg, for the grant of a Club Liquor Licence in respect of the Jewish Guild and at the premises of the Guild.

2.—That the foregoing Resolution, if carried, be submitted to the members of the Guild by a referendum through the post for their approval or otherwise, such referendum to be decided by a majority of votes.
