The provision made in the will of the late Mr. Hyman Liberman for the erection of an arch at the bottom of the Government Avenue is again in the limelight.

The select Committee on Crown Lands recommended that a grant of 1,600 square feet of Parliament House grounds be made to the Cape Town Municipality and on Thursday night the Hnuse accepted the recommendation.

As soon as the Assembly met on Thursday afternoon Mr . Speaker referred to certain procedure recently followed in the House of Crown Land, which in his opinion was highly undesirable.

He referred to the grant of ground for the erection of the "Liberman Archway".

The question of interfering with the Parliamentary Buildings and grounds is one which affects the privileges of members of both Houses", said Mr. Speaker, "and the least that should have been done in this instance was for the responsible Minister to consult the President of the Senate and
myself in the matter before any papers dealing with the subject were laid upon the table of either House. The course that would have been followed would have been to refer the matter to the Select Committee on Internal Arrangements of both Houses. sitting jointly, through which body any proposal to alienate any portion of the Parliamentary ground should, in my opinion, reach Parliament."
Scrutiny, said Mr. Speaker, had not in the past been applied by the chief officers of the House to the papers regarding the disposal of or otherwise affecting Crown Lands, which were from time to time tabled by the Minister of Lands and which, as a matter of practice, were thereupon automatically referred to the select Committee on Crown Lands for consideration, otherwise the proposal reterred to would not have been allowed to go to the Committee in question without his attention being drawn to it, thus enabling him to take the necessary steps toacquaint the House with his views upon it.
"I cannot say", Mr. Speaker concluded, "whether the President of the Senate was consulted before hand, but I certainly was not. I do not see that this House or I can now intervene, and I have, therefore, to content myself with drawing attention to the matter, in the hope that no future encroachments on the site over which the two Houses of Parliament exercise direct supervision will be embarked upon before such consulation as 1 have indicated is sought by the Guvernment department concerned."

Mr. P. Van Heerden asked whether he could discuss the matter.
"No, There is nothing further to be said about it," replied Mr. Speaker.
