THE "SHOOL" MEETING.

GUILD ACTIVITY.

The year 5687 was ushered in with all due solemnity on Wednesday evening. All the Peninsula Synagogues were crowded with worshippers throughout the Holy Days. Even the "Minyanim" arranged in the town and suburbs had record congregations. Both local journals devoted many columns to seasonal greetings, whilst "messages" appropriate to the occasion were given prominence. The town was unnaturally quiet-eloquent evidence of the large part played in trade and commerce by Jewry. Practically every other shop in the principal streets displayed the usual "Closed for the Holy Days" notice, and yet, one regrets to say, here and there one found premises, with Jewish owners, shamelessly showing a disregard for the importance of the High Festivals, by keeping their doors open when the mass of their fellow Jews are at prayer and meditation.

Mr. Harry Harris, president, occupied the chair at the annual meeting of the Cape Town Hebrew Congregation, which was held on the morning of the 5th inst. There was a representative gathering of members, who, being in an amiable mood, expeditiously despatched the business before them. Mr. Harris moved the adoption of the report and balance sheet, and this was seconded by the Treasurer, Mr. S. Goldstein. A comprehensive discussion was instituted by Mr. Alex Thal and after the various observations and questions had been disposed of by the Hon. Treasurer, the Report and Balance Sheet were unanimously adopted. The next item on the agenda was to elect five members of the Committee. The retiring members were Messrs. M. Rosen, H. J. Stodel, Harry Harris, L. Kramer, and J. Gesundheit. The latter, who is shortly leaving for Palestine, did not seek re-election, and whilst the first four named did, there were three nominations for the fifth seat. They were Messrs. Isaac Ochberg, I. J. Honikman and J. Frank. Voting was by ballot and resulted in the following being elected: Messrs M. Rosen (113), L. Kramer (113), H. J. Stodel (105), H. Harris (102) and J. Frank

After certain expenditure on necessary repairs had been confirmed, a motion by Mr. A. M. Jackson in regard to the question of proselytes was withdrawn.

It was unanimously decided that the congregation affiliate with the South African Zionist Federation and another unanimous decision was that a new motor car be purchased for the minister.

Messrs. Levy & Co., were re-appointed auditors for the ensuing year.

There was much gaiety at the Guild Rooms on Tuesday night when a Mock Mannequin parade and fashion display was held. The hall was packed and many were unable to gain admittance. The proceeds were ear-marked for the United Hebrew School, and that Institution will benefit to the extent of over £17.

The parade of the "mannequins" was a screamingly funny affair. Their make-up was perfect, but the "lovely" gowns "fitted where they touched." But for this is would have been very difficult in many cases to detect that the mannequins were there males. Coiffures had received extra special attention, and there was a "Willie Clarkson" touch in the various styles affected-whether previous to or after the advent of the bob, shingle and Eton crop. There were sixteen mannequins in the parade, and this was followed by a "Tea Party" which created much merriment. The hostess, an elderly dignified person, with lorgnette complete, was succussfully portrayed by Mr. S. Winer, whose deportment and gestures were perfect.
