

THE BRAMSON BANQUET.

The great event in Johannesburg this week has been the holding of the banquet which was tendered to Dr. Leon Bramson by the Executive Committee of the Central Organisation in South Africa of the Reconstruction Campaign in Eastern Europe. The occasion was made memorable by the Presence and speech of the Hon. Mr. Walter Madeley, Minister of Posts and Telegraphs, who took the place of the Hon. Tielman Roos, K.C., who had previously been expected to speak. Unfortunately, circumstances prevented his attendance, but the remarks made by his representative, also a member of the Union Cabinet, were pregnant with meaning. If there is anything tangible in the hope expressed by Mr. Madeley "that South Africa would be improved by a further adm: "then admixture of Jewish people," then it must mean that the immigration uthorities are going to look kindly on the attempts to bring some of the poor suffering Jews from Eastern Europe to this haven of security.

In the course of his remarks Mr. Madeley referred to Mr. Amery's speech at Durban, saying that this epitomised the position and crystallised the opinions of South Africans

ern Europe, urging those present to assist by contributing as generously as they could to the efforts being made to succour their unfortunate brethren.

Rabbi Dr. Landau proposed the toast of "Distinguished Guests," and in the course of his remarks said: "I have no confidence in Russia or Poland, but I have confidence in the British nation and the Dutch Government of South (Applause.) There is no flag the Jews respect more than the flag of Great Britain. (Applause.) I can assure Mr. Madeley and the other members of the Cabinet that no Jew is ungrateful to the Dutch. The Jew is indebted to his Dutch brethren for their wonderful hospitality long before the British took possession of this country.

The Mayor of Johannesburg replied and in the course of paying a tribute to the Jewish people and to their pre-eminence in every direction in which they strove to take an active part, he said he could not understand any man belonging to the Jewish religion not liking that flag which had cared for him for centuries. (Applause.) There was no nation that enjoyed such world-wide respect as the British nation, which had stood by every weak community.

There were about 200 people present at the gathering, fully representative of the Johannesburg Jewish community as well as a number from Bloemfontein, Germiston and other Reef towns. During the course of the evening several letters and telegrams were read, notably one from the Prime Minister, in which he said: "As previously intimated, am unfortunately unable to be present at dinner in honour Dr. Bramson. May efforts of your distinguished guest for the reorganisation of his people meet with success and be conducive to a firm re-establishment of peace and goodwill.—General Hertzog."

The Private Secretary of the Minister of the Interior wrote as follows: "Dear Sir,-In reply to your letter of the 28th inst., I am directed by the Minister of the Interior to express his regret that his journey to East London will prevent him from attending the banquet at the Carlton Hotel on the 3rd inst. He desires to thank your Executive Committee for the invitation extended to him. Dr. Malan desires me to add that in his opinion South Africa's greatest need is a large increase of productive activities and that any diversion of Jewish capital and talent in that direction can only be welcomed by its people. He therefore hopes that Dr. Bramson's efforts will meet with success."

Mr. Tielman Roos wired:

"Please express my regret at not being able appear to-night. Strain of work telling on me. Trust that you will have very successful function endorsing great and unselfish work being done by Dr. Bramson. Greetings."

The famous Arctic explorer and head of the Refugees' and Emigrant Section of the League of Nations, Dr. Fritiof Nansen, sent his greetings to the banquet in the following terms: "On this occasion I beg to express my heartiest wishes for success in your great humanitarian activities, with which I had the pleasure of being associated."

The Head of the Labour Bureau of the League of Nations, Albert Thomas, wired the following from Geneva: "My best wishes for the success of your cause, and I beg to assure you of the co-operation of our Bureau for the future as heartily as it has been in the past."

Professor Dubnow, of Berlin, cabled: "I heartily greet South African Jewry in its endeavours to support the important reconstruction work of the Organisations 'Ort—Ose and Emigdirect' for the welfare of our suffering brethren."

Messrs. Spielman, Otto Schiff, Halpern, Schalit, Gavronsky and Joseph Prag cabled: "Please accept our heartfelt wishes for success. Thorough reconstruction and well considered plans of migration are the most urgent problems that face us, and we rejoice at the thought that the young and powerful community of South Africa has now assembled to lend its own shoulder in support of this great work."

Rev. Bender, of Cape Town, wired: "Regret cannot join personally in tribute to distinguished philanthropist. Feel confident Johannesburg will respond with characteristic generosity to Doctor Bramson's appeal." And Advocate Morris Alexander, M.L.A., telegraphed: "Regret unavoidable absence banquet Dr. Bramson. Wish campaign every success. Trust South African Jewry will help generously in accordance with its noble traditions." While from Bloemfontein came the following encouraging communication: "Wishing your Executive every success in noble effort to assist a real Jewish cause in a real Jewish manner. Count on every assistance Bloemfontein Jewry, whose heart now as always beats true.-Sol Harris, Chairman, Bloemfontein Campaign Committee."

As a consequence of the dinner and the speeches made and of a previous canvass that had been conducted, a sum of £4,000 was declared to have been received or promised.

AN INTERESTING LECTURE.

Under the auspices of the Women's Zionist League last week Dr. Sniderman delivered an interesting address upon "Dreamers of the Ghetto." Starting with the Venetian Ghetto, he described the humiliations and sufferings under the Spanish Inquisition, and in France, Germany and the England of Richard I. This long agony had bred a race of dreamers, who looked to the coming of the Messiah for salvation. The lecturer then told of Sabbatai Zevi, the false Messiah, whose story is contained in Zangwill's book. He also traced the lives of others mentioned by Zangwill, Spinoza, Uriel Acosta and Theodore Herzl, concluding with a panegyric on Dr. Herzl, who had done so much to turn his dream into reality.

Police Invade Synagogues.

The Jewish Telegraphic Agency Budapest correspondent reports that acting on an order from the Ministry of the Interior, police have raided a number of towns in the north-eastern parts of the country, searching for aliens to be deported from the country. Several synagogues were broken into during service and many Jews were arrested. Three hundred and twenty-one persons, mostly Galician and Bukovinian Jews, have been placed in the Aliens' Deportation House, awaiting deportation. Many of these have been permanently resident in Hungary for the past thirty years.

Many protests have been lodged against the police action and several Deputies of the Government Party have put a demand to the Government that the raids should be stopped.

The State police deny that the raids were anti-Jewish in tendency. The Jewish community of Szerencs has sent a protest to the Ministry of the Interior against the action of the police in breaking into synagogues during service, pointing out that this is an affront to the religious feeling of the Jewish population.

During the month of June 376 persons, including 311 Jews entered Palestine. During the same month 749 persons, including 565 Jews left the country.
