

In Johannesburg PRESENTATION TO MR. B. GORDON.

There was a pleasant gathering at the residence of Mr. and Mrs. J. Janower, on Thursday evening, the 11th instant, when the members of the Executive Council of the South African Zionist Federation, and of the Board of the South African Palestine Enterprise (Binyan) Corporation, Ltd., assembled to take leave of Mr. Bernard Gordon, vice-president of the Federa-tion, and chairman of the "Binyan," who, accom-panied by Mrs. Gordon, sailed to-day for an overseas trip of several months' duration, which will include a visit to Palestine.

The proceedings were of an informal character, but Mr. A. M. Abrahams, president of the Federation, and the Chief Rabbi, Dr. J. L. Landau, took occasion to convey to Mr. Gordon the appreciation of South African Zionists for his work for the Cause, and the warm personal regard in which he is held by his colleagues.

The occasion was also taken of presenting Mr. Gordon with an illuminated address, in the course of which was stated :-
