JAM van Schoor said that what was agreed upon (item 2(f)) was used as a basis for negotiations with the Kaya Mandi Town Council and that if the minutes are not correct then the 2 meetings held with the lastmentioned Council, where certain agreements were reached, could have been a waste of time.

The Chairperson agreed with C Withington that what was meant was that if the idea of the provision of and payment for services was accepted by the community then provision will be made by the ANC/SANCO alliance for the payment of accounts.

  - (i) extend the present financial agency agreement to obtain the right from Kaya Mandi Town Council to act on their behalf regarding the issuing of accounts (on municipal documentation) and the receiving of payments subject thereto that all monies received be placed in a set of accounts:
  - (ii) request Kaya Mandi Town Council to reconsider the tariffs applicable in Kaya Mandi by:
    - the phasing-in of tariffs for conventional housing to eventually be equal to Stellenbosch
      - the levying of affordable tariffs for informal areas
  - (iii) request Kaya Mandi Town Councillors not to use the Administration offices for local government affairs in the event of the vacating of the said offices by the SANCO/ANC alliance to facilitate the aforesaid administrative proceedings;
- (d) that the necessary legal requirements be met in the above regard;
- (e) that it be noted that all monies in arrears by residents payable to Kaya Mandi Town Council be frozen and that accounts will start with zero arrears from 1993-10-01;
- (f) that the meters will be read on 1993-10-01 by staff of Kaya Mandi Town Council under the supervision of Stellenbosch Municipal officials; and
- (g) that it be noted that SANCO/ANC alliance will provide specific commitments during the SDF meeting of 1993-10-07 regarding the vacating of the Administrative offices."

#### FOR CONSIDERATION.

5.1 MC Ntsomboti referred to item 2.1(g) of the Special CWC meeting held on 1993-09-27. He said that the ANC/SANCO alliance held 2 general meetings where they tested their constituents on the question of provision of and payment for services as from 1993-10-01 and they got an undertaking from everybody that they will pay for services when they get their accounts.

Regarding the occupation of the Kaya Mandi offices he said that 80 % to 90 % of their demands which had been addressed to the CPA have not been met.

He however reiterated that these demands were not directed at Stellenbosch Municipality and the SDF but at the Kaya Mandi Town Council and Cape Provincial Administration. If so required, some office space at Kaya Mandi as well as the required office equipment (computers, records, etc) will be made available for the payment of accounts.

JAM van Schoor asked for a short recess to enable his delegation to discuss the matter in private.

After the recess, JAM van Schoor said that Stellenbosch Municipality would not like to be involved in the quarrel between the Alliance, the Kaya Mandi Town Council and the Cape Provincial Administration. The importance of the Kaya Mandi Town Council as the only statutory body in Kaya Mandi could not be ignored because their permission must first be obtained before any services can be rendered. The offer for the use of some office space at Kaya Mandi could however not be accepted and an alternative pay-point had to be found. The relevant equipment and records were however required for the issuing of accounts and the offer of the ANC/SANCO alliance will be accepted in this respect.

He further referred to items 2(e) to 2(g) of the minutes (Special CWC: 1993-09-27) and said that the necessary agreements were reached with Kaya Mandi Town Council regarding the issuing of accounts (in the name of Stellenbosch Municipality), the depositing of money received in a special account, the freezing of arrears, the reading of meters and the levying and phasing-in of tariffs. The aforementioned were however agreed to by the Kaya Mandi Town Council after they were informed of the commitment by the ANC/SANCO alliance as reflected in item 2(f) of the DWC minutes of 1993-09-23. This new information regarding the occupying of the offices must now be conveyed to the Kaya Mandi Town Council, which may affect the situation negatively.

MC Ntsomboti said that if the Kaya Mandi Town Council respond in a negative fashion then another meeting should be held to address the matter, but JAM van Schoor felt that it was not necessary.

#### AGREED

- that the matters agreed upon at the Special DWC meeting held on 1993-09-23 as further ensued and amended by the Special CWC meeting of 1993-09-27 be approved; and
- (b) that the reports by MC Ntsomboti and JAM van Schoor be noted.

MC Ntsomboti said that a mission statement is something new and need to be discussed first. If the proposed press statement is a problem, then he would ask for a short recess to discuss the matter with the Alliance.

After the recess, MC Ntsomboti said that the Alliance is prepared to accept the Declaration without the proposed press statement.

AGREED (as proposed by MC Ntsomboti and seconded by JAM van Schoor)

that the Declaration of Intent only, as amended under 5.2, be accepted.
